

**LIMAVADY BOROUGH COUNCIL
COMHAIRLE BHUIRG LÉIM AN MHADAIDH**

**ANNUAL GENERAL MEETING
3 JUNE 2008**

Minutes of the annual general meeting held in the Council Offices, 7 Connell Street, Limavady, at 7.00 pm on the above date.

OUT-GOING MAYOR'S REMARKS:

Councillor Stevenson thanked his family for supporting him throughout the year. He also thanked Alderman Rankin for his advice & guidance and to Council staff for helping him during his year in office.

Councillor Coyle congratulated Councillor Stevenson for his hard work and said it had been a difficult year due to job losses and arson attacks in the Borough, however Councillor Stevenson had been at the forefront when he was needed.

The out going Mayor was also thanked for his work by Alderman Rankin, Councillor Robinson and Councillor Cubitt.

ELECTION OF MAYOR 2008/2009:

Councillor Stevenson sought nominations for the office of Mayor for 2008/2009.

Councillor Brolly proposed and Councillor Butcher seconded that Councillor Chivers be elected to the position of Mayor in 2008/2009.

MAYOR'S REMARKS:

Councillor Chivers took the Chair and signed the Declaration of Acceptance of Office. She thanked members for electing her as Mayor and said it was with a great sense of pride to assume the office of Mayor of the Borough and to become

the 2nd lady Mayor, the first being party colleague Councillor Brolly. She said she was also honoured to be the 1st Mayor from Drumsurn, and the first Canadian citizen to hold the position.

Councillor Chivers explained that she was not a native of Limavady, but had emigrated to Toronto from Belfast where she had met her husband Liam who was from Drumsurn. She said since returning to Ireland with their four children, the family had made the Borough their home and was active in the local community life in Drumsurn. She added that she had a good relationship with both sections of the community through her work and social environment and that as Mayor, she would continue to build on the good foundation laid down by former Sinn Féin colleagues and extend the hand of friendship to everyone, regardless of their religion, political beliefs or background.

She referred to job losses in the Borough and gave assurance that she would do everything she could to attract investment into the area. She said sport had always been an important aspect to her family and that she would encourage all sporting bodies to reach their full potential.

Councillor Chivers thanked her family for agreeing to support her over the year. She pledged to do her best to live up to the responsibilities bestowed on her and asked for members to be supportive in carrying out her duties on behalf of the people of the Borough. Councillor Brolly indicated that Sinn Féin party members would fully support Councillor Chivers in her role as Mayor.

ELECTION OF DEPUTY MAYOR 2007/2008:

Councillor Robinson proposed, seconded by Councillor Cubitt that Alderman Robinson be elected as Deputy Mayor for the year 2008/2009. Agreed.

18. **Irish Language Sub-Committee (4): 2SF, 1 SDLP, 1 DUP and 1 officer):** Councillor Butcher, Councillor Ó hOisín, Councillor Coyle and Culture Arts & Tourism Manager were re-elected to serve on this committee, with 1 unallocated seat.
19. **Limavady Arts & Cultural Committee: (2 members plus relevant Council Officers):** Alderman Mullan and Councillor Cubitt were re-elected to serve on this committee.
20. **Limavady Community Development Initiative & Advice Services Sub Group (2, plus 1 Officer):** Councillor Cubitt, Councillor Ó hOisín and the Director of Development were re-elected to serve on this committee.
21. **Limavady Community Safety Partnership (2 of which at least 1 should be a member of the DPP):** Alderman Rankin and Councillor Coyle were nominated to the above partnership.
22. **Limavady Road Safety Committee (Open to any interested members):** Councillor Cubitt and Alderman Mullan were re-elected to serve on this committee.
23. **Limavady Sports Advisory Committee (4):** Councillor Carten, Alderman Robinson, Councillor McElhinney and Councillor Ó hOisín were re-elected to serve on this committee.

37. **Westport Twinning Committee (6) the Mayor ex officio and 5 members, plus the Director of Development and the Chief Executive:** It was agreed that Alderman Mullan, Councillor Carten, Councillor Coyle, Councillor McElhinney, Councillor Ó hOisín and the Mayor Councillor Chivers would serve on this committee.

ANY OTHER BUSINESS:

Committees Not Renewable at this time: The list of committees not required to be renewed at this time was noted by members.

The Chief Executive drew attention to the fact that the Disability Working Group and the Sustainable Development Working Group were not included on the list and did not require re-appointment at the AGM.

It was agreed that the Limavady Town Centre Forum would be disbanded.

Court of University of Ulster: It was agreed on the request of Councillor Butcher that the Chief Executive would write to the University of Ulster regarding nomination from Limavady area to the Court of University of Ulster.
